- Re: B3 Respite Services and Providers

B3 Respite services provide recurring support and relief to primary caregivers of children (ages 3 to 21) and adults with an intellectual/developmental disabilities diagnosis.

B3 Respite services allow the primary caregiver(s) to participate in scheduled and unscheduled events away from the child or adult participant, while care is delivered by appropriately trained staff.

B3 Respite services may be delivered in a variety of ways. These may include:

- weekend care
- emergency care (family emergency based), or
- continuous care (for up to ten days).

B3 Respite may include

- in- and out-of-home services
- activities in a variety of community locations and
- overnight services.

You may be eligible for B3 Respite services. As with any I/DD service, you have the right to choose your provider. Enclosed is a listing of B3 Respite providers for the Partners BHM area, complete with contact information. If you are interested in receiving B3 Respite services, you may contact the provider of your choice to begin the process.
