Title I Program Overview

- Title I is a federally funded program
- Provides funding for schools to help students who are behind academically or at risk of falling behind to meet state standards
- Schools qualify for Title I funds based on the school's percentage of free lunch recipients

Title I Program Overview

Pinewood participates in a Title I Schoolwide Program

- Schoolwide programs have flexibility in using their Title I funds to enhance instruction.
- Schoolwide programs must:
 - conduct a comprehensive needs assessment
 - identify and commit to specific goals and strategies that address those needs
 - create a comprehensive plan
 - conduct an annual review of the effectiveness of the program.
