Addendum: Clarification Items

Update to Bid Event Schedule:

On December 13, 2024, at 9:00am, the public bid opening for the above referenced five (5) projects occurred at 943 Osceola Street, Gastonia, NC as planned. The sign-in sheet from the bid opening is attached to this Addendum 2 for reference. Four (4) of the five (5) projects listed above received three (3) Bids each and so therefore Bids for those projects were opened and the Bid Tab was certified. Gaston County Schools intends to select Contractors for those four (4) projects from among the Bids received.

One (1) of the projects, Catawba Heights Elementary School, only received two (2) Bid envelopes. Therefore, Bids for Catawba Heights were not opened.

An additional opportunity is being created for additional interested Bidders to submit a Bid on the Catawba Heights Elementary School project only.

Monday January 6, 5pm	Deadline for Architect to issue any final Addendum (including response to questions received, if any).
Tuesday January 14, 3pm	Public Bid Opening #2, 943 Osceola Street, Gastonia, NC Catawba Heights Elementary School project only.
