Gaston County Schools is interested in obtaining a Request for Qualifications (FRQ) from interested vendors for the work described herein.

The school will be 2-story and approximately 165,000 SF in area; including: classrooms, gymnasium, administrative areas, basement and kitchen/cafeteria. The school will incorporate chilled water and heating hot water primary, and secondary systems; served by air-cooled chillers and gas-fired boilers, respectively. The terminal distribution system will consist of both indoor modular air handling units and rooftop units equipped with gas heat. Individual zones are served by variable air volume (VAV) terminal boxes.

The Owner will NOT seek LEED or Green Globes certification for this project.

Conduct a second controls integration and interoperability meeting to verify contractors understand their roles and responsibilities associated with controls integration.
