MINUTES

The Gaston County Board of Education met in a regular session on Monday, March 15, 2021 in the Board Room, 943 Osceola Street, Gastonia, NC. The Board of Education meeting was held virtually and conducted in accordance with social distancing requirements related to the coronavirus pandemic. The meeting was live on Spectrum Cable Channel 21 and the Gaston County Board of Education YouTube page. Those Board Members in attendance were: Chairman Jeff K. Ramsey, Vice Chairman Dot Cherry, Kevin Collier, Justin Davis, Lee Dedmon, Dot Guthrie (virtual), Steve Hall, Robbie Lovelace and Brent Moore.

Chairman Ramsey called the meeting to order at 5:33 p.m. and welcomed everyone.

Good News – Information

Typically, we open each Board Meeting with “good news” about our schools, students and employees. 2021-2022 Superintendent's Budget Request – Information

Chairman Ramsey recognized Mr. Gary Hoskins who presented a PowerPoint on Superintendent's Budget Request. Discussion followed.

Funding for Capital Projects – Action

Chairman Ramsey recognized Mr. Gary Hoskins who gave an update on funding for Capital Projects. Proceeds received from the sale of school bond funds are deposited by the County into an interest-bearing account. As the school district uses these funds, the funds are withdrawn from the County's interest-bearing account and used for the authorized capital needs of the school district. Over time, the interest earned on these unused school bond proceeds increases and needs to be reallocated back to the school district. We must request approval from the County to reallocate funds in order to be able to use these funds for the capital needs of the school district.

In 2016, the County issued \$50 million bonds for the purpose of building the new Pleasant Ridge Elementary School and Stanley Middle School. These two schools were completed under budget resulting in unused proceeds of \$707,550. We must request approval from the County to reallocate these funds in order to be able to use these funds for the capital needs of the school district. These reallocated funds would be used to provide funding for a paving project at Bessemer City Middle School.

Authorize the Superintendent or his designee to request that Gaston County Commissioners reallocate interest earned from school bonds in the amount of \$2,053,668 to be used to fund capital projects throughout the district. Also, authorize the Superintendent or his designee to request that the unused principal from the 2016 school bond in the amount of \$707,550 be reallocated for the purpose of funding a paving project at Bessemer City Middle School.

A vote was taken and motion to approve the item as presented carried unanimously. (9-0)

Superintendent's Comments

Superintendent Booker announced that registration for kindergarten and pre-kindergarten is taking place now and parents can complete the registration process on the district website.

Superintendent Booker reported that one year ago Governor Cooper announced the closure of school buildings as concerns about the coronavirus swept across the country. That was the beginning of “unprecedented times” for school districts as we “navigated the uncharted waters” of conducting school like we never have before. All of us are cautiously optimistic that we are turning the corner with the pandemic, but we know that we must stay vigilant. As we continue to look forward to better days and an eventual return to normal, we cannot say “thank you” enough for the leadership and support we have experienced over the past year from the board room to the classroom.

Superintendent Booker thanked our local healthcare partners, the Gaston County Department of Health and Human Services and CaroMont Health for their efforts to provide the COVID-19 vaccine for educators.

Superintendent Booker announced that report cards will be distributed for all grade levels on Thursday, March 18.

Superintendent Booker announced that Friday, April 2 is the spring holiday which means no school for students and employees and our central office locations will be closed. The week of April 5-9 is spring break week and our school buildings will be closed and central office buildings will be supporting any concerns.

Chairman Ramsey wished Mrs. Robbie Lovelace a "Happy Birthday."

On behalf of the Board Mr. Kevin Collier reported the following:


The lawsuit captioned *T.J. Solomon, II as Guardian Ad Litem for A. Payne vs. The Gaston County Board of Education, Joey Clinton and Lorinda Brusie*, in Gaston County Superior Court, Case No. 19-CVS-319 has been settled. The Board's insurer, Liberty Mutual Insurance Company, agreed to pay plaintiff \$70,000 in exchange for a full dismissal of the litigation. The settlement is not an admission of liability, but rather a strategic decision by the Board's insurance company to avoid the costs of further litigation and to obtain a dismissal and full release of all claims. A copy of the settlement agreement will be maintained in the Board's records.



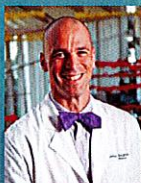

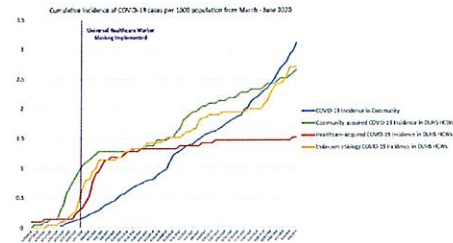
Dramatic care vs. routine Care

- Prior to being approached about schools, we had months of experience providing medical care in the pandemic
- There is a substantial difference in risk providing care for intubated, critically ill, COVID test+ patients and routine medical care
- Routine care: test status unknown, no symptoms, provider with a medical mask (not N95) and patient/family member with cloth mask
- In rooms 8' x 8', variable ventilation
- March 2020-December 2020
- January 2021-present



How we got started

- Prior to universal masking compliance (mid-April), the **red line** (HCW work-related infections) quickly rises throughout March and early April. Compare the slope of the **red line to the blue line** (community) prior to policy and widespread adoption. After we had the masking policy and widespread adoption, the new infections in HCW **related to being at work virtually stopped**.
- While work-acquired COVID-19 dropped to near-nil, HCW still acquired plenty of COVID-19. But April-December we got COVID-19 in the community, just not at work*
- So when school boards called in summer 2020, we talked to them about infection control rather than community metrics
- Key question for all of us: can we have a safe environment in schools
- Of note: these data have been replicated in hundreds of hospitals across physicians, nurses, technicians, cafeteria workers, transportation, custodial services, phlebotomists. This work has also been replicated in outpatient clinics, free clinics, health department clinics where the ventilation is poor



- *Now that we have been vaccinated, risk is extremely low

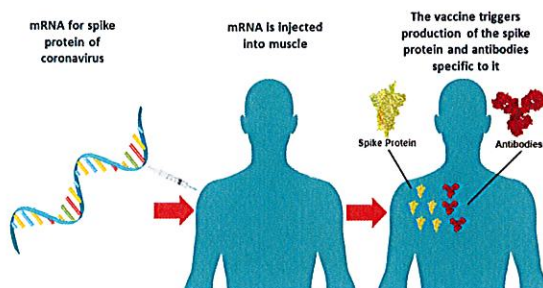
- 11 school districts; >90,000 students and staff attended school in-person; first 9 weeks of instruction
- 773 community-acquired SARS-CoV-2 infections were documented by molecular testing
- Through contact tracing, additional 32 infections were acquired within schools
- No instances of child-to-adult transmission of SARS-CoV-2 were reported within schools

- mRNA vaccines do not use the live virus that causes COVID-19.

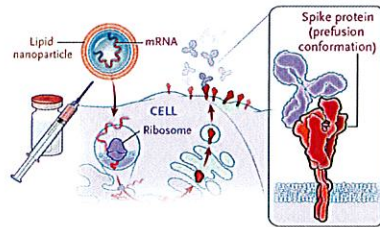
They do not affect or interact with our DNA in any way.

- mRNA never enters the nucleus of the cell, which is where our DNA (genetic material) is kept.
- The cell breaks down and gets rid of the mRNA soon after it is finished using the instructions.

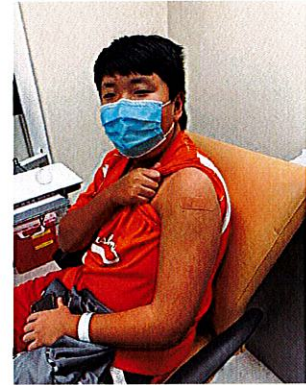

- Vaccine effectiveness study: 1.2 million people
- Effectiveness after first dose
 - Prevent any infection—46%
 - Prevent symptomatic COVID—57%
 - Prevent death—72%
- Effectiveness after second dose
 - Prevent any infection—92%
 - Prevent symptomatic Covid—94%
 - Prevent death—100%

Pfizer: 16-18yo (summer 2021); 13-15yo (fall) <12 enroll (winter 21-22)
Moderna, J&J: think 3-6 months later
AZ, Novavax: timeline unknown (need EUA) think late 2021

Sports and mandatory vs encouraged
Staff and mandatory vs encouraged

Other thoughts

- Cleaning
 - Only 3 cases of fomite transmission reported in the worldwide literature; none in schools (culture)
- J&J vaccine
 - Higher rates of symptomatic COVID-19 in the trials
 - 100% effective in preventing death hospitalization in the randomized trials
- Variants
 - Evolution & probability
 - We will likely deal with COVID for years
 - Get vaccinated, continue prevention-mitigation until everyone vaccinated
 - Get mitigation strategies into place and know that we'll likely need to use them at least periodically
 - Boosters are likely in our future

- High School and Middle Schools Should be in Plan A (or at least offered the option of Plan A), provided that
 - Oversight and transparency of infection data
 - Plans submitted to NC DHHS and agree to follow NC DHHS tool kit
- Best predictors of success in Plan A
 - Strong mitigation, especially mask adherence
 - Plans to ensure mitigation
 - Success in Plan B
 - Plan A should be safe for Gaston

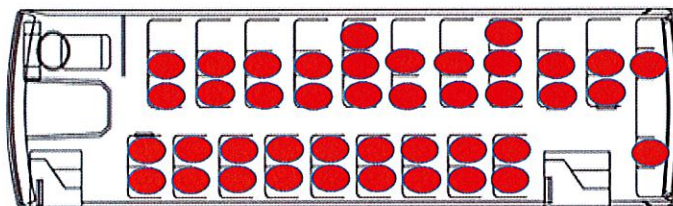

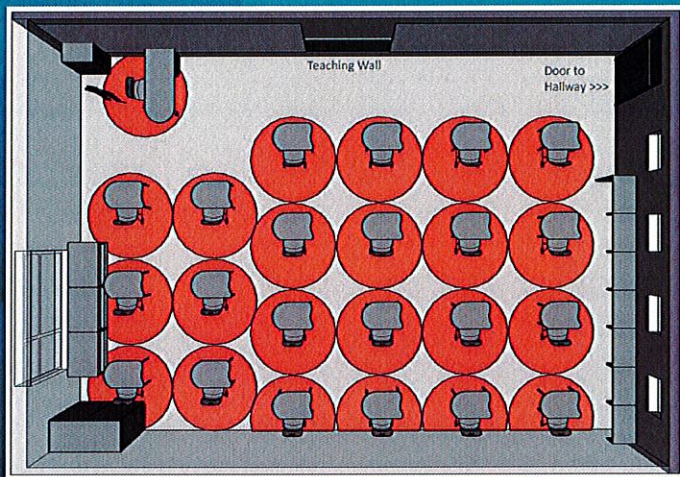

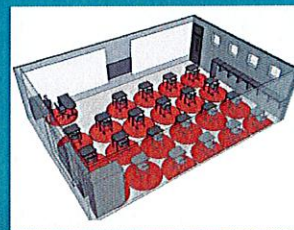
COVID 19 Classroom Layout

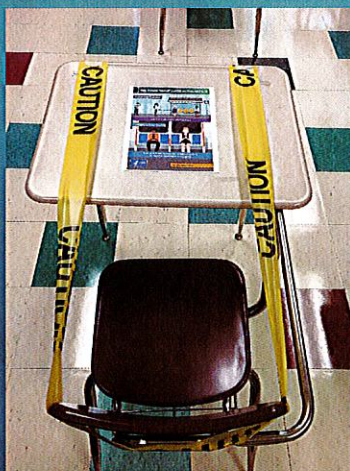


**COVID 19 Classroom Layout

Board of Education Meeting
Operations Committee Report

The Operations Committee met on Monday, March 1, 2020 at 4:00pm here in the Central Office Board Room. Our committee consists of Chairman – Lee Dedmon, Kevin Collier, Dot Cherry, and Brent Moore.

Our agenda and discussions included the following:

1. Chris Hall and Dr. Leigh Smith gave an update on the School Business Systems Modernization (SBSM) project. The SBSM project is state funded by the North Carolina Department of Public Instruction. Cherry Road Technologies is the state selected vendor to assist districts that are moving to Oracle Cloud as their new business management system. Oracle will be replacing our district's primary Human Resources, Finance, and Payroll systems. Gaston County Schools is scheduled to go live with Phase 1 of this project on July 1, 2021.
2. Joey Clinton shared with us additional dates, times, and locations that the Covid-19 vaccinations were available to GCS employees that wanted to receive the vaccine before March 10. Gaston County Schools was part of an early group 3. Mr. Clinton also informed us that jobs are posted online for internal employees to apply for positions at the new Gaston Early College of Medical Sciences and at the Gaston Virtual Academy. Interviews will start this month for Principal and Assistant Principals.
3. Our Chief Technology Officer, Aaron Slutsky, and other TSS personnel, informed us of the new process they have implemented to help the district reroute the network in case of a WAN or LAN internet outage. The process will help to backup and restore data quickly as well as maintaining internet in our schools and offices.
4. Dr. Morgen Houchard, Executive Director of Auxiliary Services, reported on the following items which relate to the Auxiliary Services Department:
 - The first full day for Cohort A and Cohort B on the elementary level was a success thanks in part to the hard work and dedication of our school leadership, school employees, and students.
 - Renovations to the C Wing at Highland School of Technology will be listed on the Consent Agenda for Board approval.
 - AT&T has proposed to place a cell phone tower at McAdenville Elementary. More information will be gathered and then brought back to the Operations Committee.
 - A local realtor is requesting access to a development off of One Learning Place at Forest Heights. At this time, the Operations Committee has agreed to leave it as is, which keeps ownership and access as is.
 - An update to the Rocky Branch Carolina Thread Trail, near Sturt Cramer High School, was given.
 - We now have the Temporary Certificate of Occupancy for the new Belmont Middle School. At this time, 98% of the punch list items has been completed. Furniture is being moved and

the traffic light at the intersection of Wildcat Way and South Point Road is currently working.

5. Associate Superintendent and Chief Financial Officer, Gary Hoskins, presented information pertaining to School Bonds and how the funds have been disbursed. Funding for Capital Projects will appear on the agenda as an Action item. The Board will receive the Superintendent's Budget Request, which is based on information received from our stakeholders and Fund Managers, at the March Board meeting. The budget will be presented to the Board for approval on April 19, 2021 and then submitted to the County by May 15, 2021 as required by State law.
6. Gary Hoskins also presented the committee with a list of construction and repair change orders which are recommended for approval by the Board. These items appear on the Consent Agenda.

Our next committee meeting is scheduled for May 3, 2021 at 4:00pm in the Central Office Board Room.

Updated information was presented on the Social Studies curriculum framework. New K-12 standards were adopted February 2021 and implementation will occur fall 2021. The new framework will be more engaging and interactive.

The meeting adjourned at 1:55 PM.

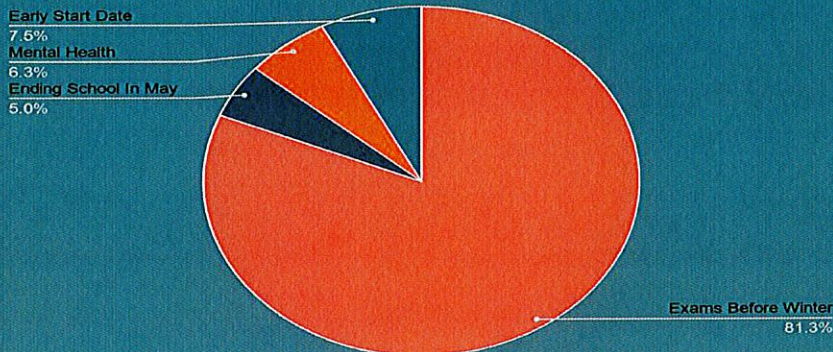

- Next year employer provided benefits is projected to increase by **\$528,000** as follows:
 - Health insurance is projected to increase by **6.0%** from \$6,326 to \$6,700;

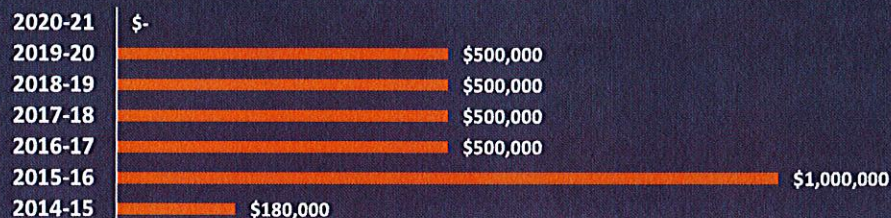

- There was **no increase in teacher supplements** for 2020-2021 due to the impact of the pandemic on local sales tax revenues.

Classified Employee Compensation:

- Salary increases for our non-certified employees (custodians, bus drivers, etc.) have lagged the increases of other similar government employees.
- A requested **3.0%** compensation increase for locally paid non-certified employees would cost **\$261,000.**

Certified Employee Compensation:

- Our certified employees (teachers, guidance counselors, etc.) have not received any increased compensation for the past two fiscal years due to the State budget impasse.
- A requested **4.0%** compensation increase for locally paid certified employees would cost **\$189,000.**

Additional Nursing Positions in Schools:

- Add **30 nursing positions** so Gaston County Schools would have one nurse for each of our 55 schools. This would provide immediate and acute medical care to students on all campuses.

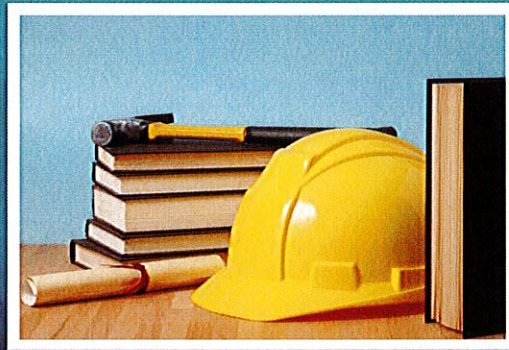

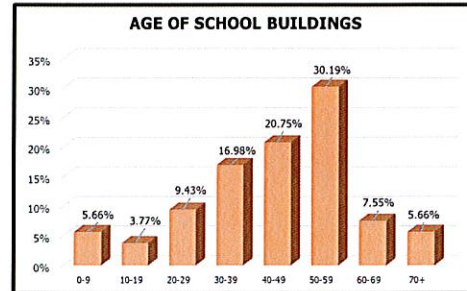

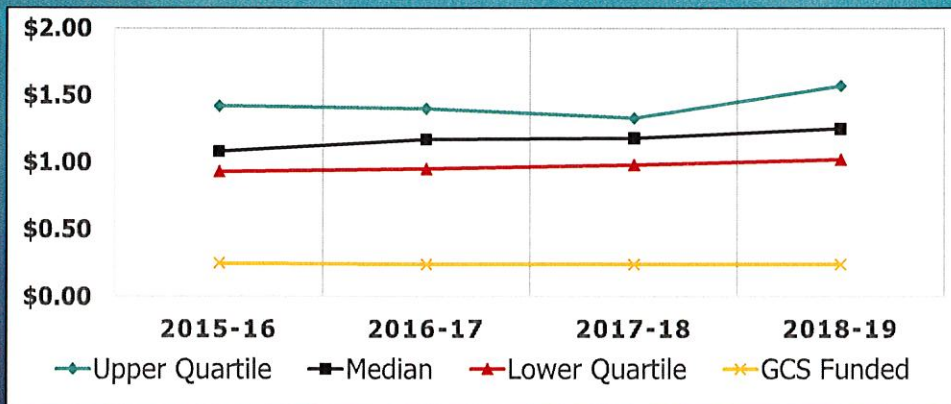

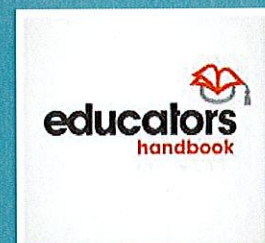
Canvas

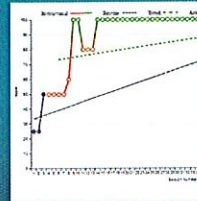
Special Funds Management

- Gaston County Schools partners with Holy Angels to provide services using these funds

- Evaluate students for services

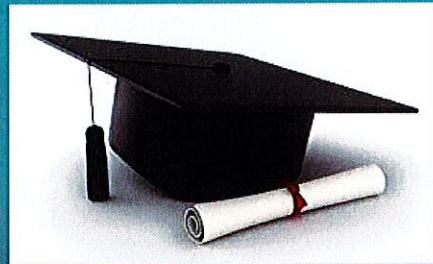

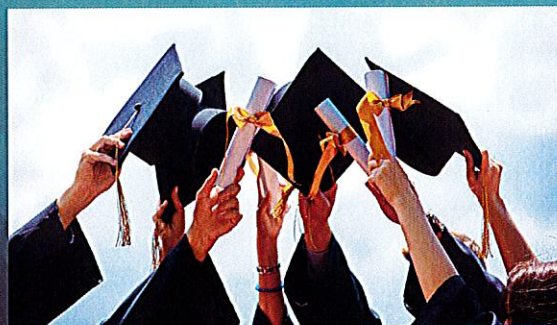

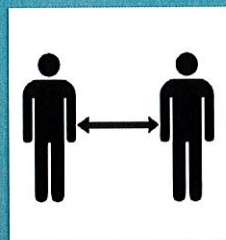
