Dear Parent/Guardian:

In October, the North Carolina State Board of Education (SBE) adopted new college-and-career readiness Academic Achievement Standards and Academic Achievement Descriptors for the End-of-Grade (EOG) and End-of-Course (EOC) tests and their alternate assessments. The Achievement Level Standards and their Descriptors allow you to compare your child's performance to grade-level/course level expectations.

In previous school years, the NC Department of Public Instruction has reported four Academic Achievement Levels; however, effective in March 2014, the SBE added a new Achievement Level 3. With the addition of this new Achievement Level, the NCDPI will now report five levels of student academic performance. The revised Achievement Levels are as follows:

Achievement Levels	Meets On-Grade-Level Proficiency Standard	Meets College-and-Career Readiness Standard
<b>Level 5</b> denotes <b>Superior Command</b> of knowledge and skills	Yes	Yes
<b>Level 4</b> denotes <b>Solid Command</b> of knowledge and skills	Yes	Yes
<b>Level 3</b> denotes <b>Sufficient Command</b> of knowledge and skills	Yes	No
<b>Level 2</b> denotes <b>Partial Command</b> of knowledge and skills	No	No
<b>Level 1</b> denotes <b>Limited Command</b> of knowledge and skills	No	No

The new Achievement Level 3 identifies students who are prepared for the next grade but do not meet the college-and-career readiness standard. Having this new level helps teachers to better meet the learning needs of the individual student. Below is the new Achievement Level Descriptor for Level 3:

**Level 3:** Students performing at this level have a **sufficient command** of grade-level knowledge and skills, but they may need academic support to engage successfully in this content area in the next grade level. They are prepared for the next grade level but will need additional academic support in order to be on track for college-and-career readiness without additional academic support.

Starting this year, your child's Individual Student Report for the End-of-Grade/End-of-Course test(s) will report both the on-grade-level proficiency standard (Level 3 or higher) and the college-and-career readiness standards (Level 4 and above). Proficiency on all state assessments will be calculated using Level 3 and higher.
